**TENDER NOTICE**

**Subject : Tender for Providing Garden Maintenance Services at the Embassy Complex and Embassy Residence**

The Embassy of India in Warsaw (hereinafter referred as Embassy) invites sealed tenders from professional companies/firms for providing Garden Maintenance Services at the Embassy Complex located at Myśliwiecka 2, 00-459 Warsaw and Embassy Residence located at Al. Roz 3, Warsaw.

2. The tenders are invited under two bid system viz. Technical Bid and Financial Bid from reputed and experienced firms having regular office.

Bidders are requested to go through the terms & conditions contained in the bid document.

4. The tender should be submitted in two sealed envelopes as below:

(a) The first sealed cover superscripted as "**Technical Bid**" should contain details of technical capabilities of the firm (with *documentary* evidence) as per Section IV.

(b) The second sealed envelope superscripted "**Financial Bid**" should contain rates only for the contract as per Section-V of the Tender Document.

(c) Both the sealed covers, should be placed in the main sealed envelope superscripted "Tender for Garden Maintenance" addressed to the Head of Chancery, Embassy of India, Myśliwiecka 2, 00-459, Warsaw and must reach on or before 6<sup>th</sup> February, 2023 by 1700 hrs. Bids may be delivered or sent by post at the aforementioned address so as to reach on or before the prescribed date and time. Embassy will not be responsible for any postal delay.

5. Embassy reserves the right to amend any of the terms and conditions contained in the Tender Document or reject any or all applications/offers without giving any notice or assigning any reason thereof. The decision of the Embassy in this regard will be final and binding upon the bidders.

## 7. **Eligibility Criteria**

The company/firm should be registered with the relevant trade/commercial office as per local laws and regulations for tax and other purposes. It should have at least 3 years' experience and knowledge in this field. The company should also have appropriate technical potential and personnel capable of performing the contract. They are also expected to possess good economic and financial standing/situation.

8. All bidders are requested to read and understand the terms & conditions of the contract before submitting their bids. No change or violation of the aforementioned terms and conditions is permissible once the quotation is accepted by the Mission.

## **Section-II**

### **Scope of Work**

1. Removing the existing turf, if required and its disposal, leveling the ground.
2. Putting fresh soil, if required.
3. Planting of good quality grass.
4. Planting of seeds, seasonal flowers and hedges.
5. Regular mowing the lawns: park, carpet, on slopes, weeds in plantings, put biomass to the landfill.
6. Cutting of lawn grass with lawnmower at regular intervals (fortnightly) or as required.
7. Taking proper care while mowing lawns with trees and shrubs to avoid damaging the plants.
8. Sweeping lanes, sidewalks and roads with cut grass while mowing.
9. Filling of patches in lawns with grass sowing.
10. Watering lawns at regular basis according to need.
11. Taking care of leaves in green areas on regular basis.
12. Weeding, pruning, removal of spoiled/dead flowers on a regular basis.
13. Watering, fertilization, protection from diseases and pests.
14. Protection of plants for the winter.
15. Forming hedges & cut-off edging with putting landfill biomass.
16. Clearing of snow.
17. Services includes labour, transportation and supervision.

## SECTION III

### TERMS AND CONDITIONS

1. At any time prior to the deadline for submission of bids, Embassy may, for any reason, whether on its own initiative or in response to the clarification requested by a prospective bidder, modify the tender document.
2. In case of any ambiguity/dispute in the interpretation of any of the clauses in this Tender Document, Embassy's interpretation of the clauses shall be final and binding on all parties.
3. The successful bidder, on award of contract, must send the contract/acceptance in writing, within 15 days of award of contract; otherwise the contract will be awarded to the next successful bidder i.e. L-2.
4. Embassy shall have the right to impose such penalty as it deems fit on the firms for unsatisfactory or partial/defective services. The maximum penalty will be restricted to one month's charges. Embassy also reserves the right to terminate the contract at any point of time during the tenure of the contract, if the services are not found satisfactory or the contractor dishonors the contract. Decision of Embassy in this regard shall be final and binding upon the contractor.
5. No request for revision/increase of approved rates during the currency of the contract will be entertained. No other charges like transportation fare etc will be payable for providing the services.
6. A brief report (on a fortnight basis) may be submitted on the works to be undertaken that month and those completed the previous month.
7. Delay in works will not be permitted on any grounds.
8. Bidders would be required to furnish the information and submit documents, as per the attached proforma, and would quote prices strictly on monthly basis only. Prices quoted should be on all-inclusive basis and shall include the cost of all services, personnel, material, transportation etc. Technical information should be given in a separate envelope.
9. The company would submit monthly invoice(s) for payment supported with certificates of completion of requisite jobs.
10. Payments will be made through bank transfer within 14 days after submission of invoices by the company.
11. The price of offer shall be expressed in Polish Złoty.
12. The validity of the bids is 60 days and the period begins with the submission deadline.
13. Under no circumstances, the successful bidder appoint any sub-contractor or sub-lease the contract.
14. The validity of the contract would be for two years and can be extended upon satisfactory performance, in no case the rates finally approved/accepted by the Embassy would be revised during the currency of the agreement.
