2	The bidder should have supplied steel cord belts during the last five years as on the original scheduled date of tender opening (first cover) and such belts should have been used for conveying overburden of any type (or) mineral of any type (or) fossil fuel like lignite/coal.
3	The Bidder should have vulcanizing press on their own for manufacture of steel cord belt of 2000mm or higher width.

- iii) **MSME units** registered with District Industries Centers (DIC), Khadi and Village Industries Commission (KVIC), Khadi and Village Industries Board, Coir Board, National Small Industries Corporation (NSIC), Directorate of Handicraft and Handloom, Udayog Aadhar Memorandum (with supporting documents in proof of manufacture), and any other body specified by Ministry of MSME shall be given Tender Documents at free of Cost and exempted from Bid Guarantee / Payment of Earnest Money Deposit (EMD) provided, the product range mentioned in the certificate(s) is the same or similar to NLCIL requirements. The certificate should be valid on the date of opening of the bid and should be duly attested by Notary Public/Chartered Accountant.

The offers are liable for rejection if they are not accompanied with a copy of valid registered certificate in case of MSME or proof / reference for having remitted the Cost of Tender Documents, Bid Guarantee amount by RTGS / NEFT.
