The following documentary evidences shall be furnished for Manufacturing proof: copy of certificate issued by Register of companies / Department of Industries and commerce / SSI certificate / NSIC / BIS / ISO certificate issued by accredited body / Excise duty invoice / Factory license / Certificate of incorporation duly attested originally signed by chartered accountant / chartered engineer / Notary with date, identity stampings. The validity of the certificate shall be ensured wherever necessary. (or) Certificate issued by Government / Government department of respective country in English language (If the certificate is in any other language other than English, authenticated translated copy of the original certificated in English shall be furnished)</p>
2	<p>The bidder should have supplied bearings for a total value of Rs.6030000.00 in one or two orders to any Govt/QuasiGovt/PSU/Public limited companies during the last five years period as on original date of tender opening. The following documentary evidences shall be furnished for Supply and financial capability proof: Copies of purchase orders, material acceptance reports / Excise Duty Invoices.</p>
3	<p>PQR 3(a):The bidder should have supplied a minimum of ten percent of the tendered quantity (any decimal value will be rounded off to next higher numeral) corresponding to all the quoted items put together and having same size as that of tendered items or higher size(s)in the tender category of bearings irrespective of suffixes. PQR 3(b): If the bidder submits PQR documents with various sizes in the tendered category (Spherical roller) bearings, NLCIL will consider the bidder for the same and smaller size bearings quoted provided the sum of such supplies shall be at least 10% of the sum of the tendered quantity of the quoted item(s). PQR 3(a)or 3(b):The above supply should have been executed in India to any Government/Quasi Government/PSU/ Public limited companies and should have worked satisfactorily for a minimum period of two years / minimum 12000 working</p>

	<p>hours within the last five years period as on the original date of tender opening. The following documentary evidences shall be furnished for Supply and performance proof: (1) Copies of purchase orders with bearing specification, material acceptance report / Excise Duty Invoice for having executed the appropriate quantities. (2) Copies of performance certificate / performance report issued by the end user with details of customer, purchase order No., period of satisfactory performance / working hours and number of bearings performed satisfactorily.</p>
4	<p>The authorized distributor / Marketing Arm/Subsidiary having valid distributorship/dealership certificate for the tendered bearings can also submit bid with necessary authentication of their principal bearing manufacturer. In such a case their principal manufacturer shall satisfy the PQR-1 condition and the bidder individually shall satisfy the above PQR-2 and PQR-3 conditions.</p>
5	<p>Note: (1) Multiple bids received for a specific make from Dealers/Distributors will be considered. However In the event of multiple bids received for a specific make of the bearing from Manufacturer, dealer, distributor, subsidiary, marketing arm then the Manufacturers bid only will be considered. (2) If the bidder is a previous supplier of bearings to M/s NLCIL satisfying the above PQR1, PQR2 and 3, it is sufficient for the bidder to mention the relevant M/s NLCILs PO Number and IRR Numbers for verification along with documents for manufacturing proof. However they will be qualified based on the past performance with M/s NLCIL. In case of unsatisfactory performance remark in the past supplies to NLCIL in this category of (spherical roller) bearings, the bidder will not be considered. (3) M/s.
